This shall include submission of application for approval (Application Fee- Rs. 20,000/- + app. taxes), and would need to undergo a short assessment for the respective QCI scheme. This process is mandatory for any CB to seek accreditation for any QCI scheme.											N.A	

***Note- This fee structure supersedes all the fee details specified in respective scheme documents.**

1. Fee is in INR and all applicable taxes shall be charged separately
2. Travel and stay arrangements for Assessment Team shall be charged as per actuals.
3. QCI has all the rights to revise the fee structure at the end of every financial year or as and when required.
4. QCI invoices are to be paid in full by the due invoice date (maximum 60 days from invoice date).
5. In case conformity assessment body is found to be a payment defaulter, the approval will be suspended / withdrawn. In the event of a suspension/withdrawal of the approval, the fee paid till the date of suspension/withdrawal shall not be refunded.
6. QCI shall take the following actions if any applicant or accredited conformity assessment body fails to pay the fee as invoiced:
 - a) Stop further processing of the application.
 - b) Do not offer approval.
 - c) Suspend and/or withdraw the approval.
 - d) Any legal action as deemed fit.
9. Approval letter/ Certificate will be issued on the receipt of complete fee.
