PROCEEDINGS OF THE 55th GOVERNING BODY MEETING

The meeting of the 55th Governing Body was held on June 12, 2019 'Mari Gold' Habitat World at India Habitat Centre, Lodhi Road, New Delhi at 11 00 hrs.

The list of members who attended the meeting is annexed at *Annexure –A* (page no. 5). Leave of absence was granted to the members who could not attend the meeting.

Welcome

The meeting was preceded by signing of an MoU between QCI & NHA for PMJAY signed by Secretary General, QCI and Dr Arun Gupta, Director on behalf of NHA in the presence of Chairman, QCI and CEO, NHA.

The Chairperson, Governing Body (GB) welcomed and thanked the members for attending the GB meeting. He further apprised the members about some of the major initiatives /activities undertaken by QCI since last GB meeting (as given below):

- a. Collaboration with National Health Authority (NHA) on Ayushman Bharat to develop a simple and swift mechanism for AB PM-JAY quality rating certification process.
- b. Quality Assurance Scheme (QAS) a voluntary scheme for Basic Composite Medical Laboratories (Entry Level) by NABL to ensure quality of test results given by the laboratory and facilitate achieving ISO 15189 accreditation over a period of time.
- Starting of GeM Vendor Assessment (effective from June 5, 2019) for carrying out Vendor Assessment for registered OEMs on GeM.
- d. Performance evaluation-cum-impact assessment of 3000 ATAL Tinkering Labs in schools & ATAL Incubation Centres under AIM as per project assigned by NITI Aayog.
- e. Sampling & Testing of added formaldehyde in domestically imported fish in the state of Goa as per the mandate given by State Government of Goa

Chairperson, also informed the members that all such activities besides adding speed and scale to QCI's activities, have also led to its recognition at the national platform, as evident from various press release that appeared last year. Some of the few projects and schemes which were highlighted are as under:

Chairperson, QCI also apprised members about some of the major outcomes of PPID steering committee (approved by GB in its 53rd meeting) held twice during the reporting period. He further, informed the members that with the launch of new schemes by NABH, NABL and NABCB efforts are being made to increase the pool of Assessment bodies and assessors to achieve the set targets.

Chairperson, appreciated the efforts of the Board members for their continuous guidance during the past year, that helped QCI to achieve its set Goals & objectives and also gain recognition at the national and global platform.

SG welcomed the members with a Glimpse of Brief activities presented through a short video clipping since last GB meeting. Thereafter, Chairperson requested the Secretary General to take up the formal discussion on the agenda.

With the permission of chair the agenda was adopted.

GB after due deliberations, accepted the recommendations of the Finance Committee for appointment of M/s T R Chadha & Co LLP as Internal Auditor w.e.f. 1/04/2019 at a quarterly fee of Rs. 1,96,000/- plus taxes (as applicable).

Item No 55.1.2 : To consider Draft Annual Report for the period 1.4.2018 to 31.3.2019.

Governing Body considered the Draft Annual Report for the year 2018-19 and concurred for its placing before the General Council in its forthcoming meeting.

II <u>Items for Information of Governing Body:</u>

Item No 55.2.1 : To note the Financial Performance of QCI and its Boards for the FY 2018-19.

The members were informed that most of the funds are held up with clients on account of enforcement of the model code of conduct and QCI was now expecting for the payments to start soon.

QCI and all its Boards booked Income of Rs.21,076 Lakhs (including advances for ZED & NMPB) during the year ending 31.03.2019 against the Budgeted Income of Rs.23, 250 Lakhs which is 91% of Budgeted Income and actual Expenditure of Rs.16,637 Lakhs during the year against the Budgeted

Expenditure of Rs.17,500 Lakhs which is 95% of Budgeted Expenditure.

The actual income and expenditure of QCI and all Boards income for first quarter of the FY 2019-20 upto May 31, 2019 was Rs.2,238 Lakhs and Rs.2,130 Lakhs respectively, against the budgeted income of Rs. 5,386 lakhs and budgeted expenditure of Rs 4,132 lakhs.
