(a) Governing Council:

Brief Details:

- (i) The Governing Council of QCI was initially constituted by the government as a part of the Cabinet decision in 1996. There were initially 31 constituent members, with equal representation from the Government, Industry and other stakeholders. Presently, the Governing Council comprises 38 members.
- (ii) The Governing Council is the apex level body responsible for formulating the strategy, general policy, constitution and monitoring of various components of QCI, including the Accreditation Boards with the objective of ensuring transparent and credible accreditation system.
- (iii) The Governing Council is headed by the Chairperson, QCI.

Term/ Tenure:

(c) Finance Committee:

Brief Details:

The Finance Committee shall consist of five members as indicated below:

- Two members from amongst nominations from the Industry Associations having expertise in financial matters / entrepreneurship,
- Two members from the Governing Body nominated by the Chairperson, QCI, and
- Sr. Director / Director (Finance)/ Designated Incharge (Finance & Accounts), QCI to function as Member Secretary (ex-officio).

The term of the members of the Finance Committee, other than the ex-officio member, shall be 2 years at a time which can be renewed for one additional term.

(e) Constituent Boards:

Members of the Board, other than ex-officio members, shall be nominated by the Chairperson of the Board and reported to Governing Body for ratification. Each Board shall function within their mandate.

QCI has five constituent boards namely:

- National Accreditation Board for Certification Bodies (NABCB),
- National Accreditation Board for Education & Training (NABET),
- National Board for Quality Promotion (NBQP),
- National Accreditation Board for Hospitals & Healthcare Providers (NABH),
- National Accreditation Board for Testing & Calibration Laboratories (NABL).
