S. No.	Description	Changes/ Modifications
1	Addendum: Penalty	i. If the agency fails to perform services within the stipulated time schedule assigned to each deliverable by the QCI team & communicated to the consultant in writing, the QCI shall, without prejudice to its other remedies under the contract, may withhold the payment and/or deduct from the contract price, as liquidated damages, a sum equivalent to 5 % of the consideration for delay, a sum maximum up to 30% of total work order amount. Upon imposition of maximum penalty, QCI may consider termination of contract pursuant to the conditions of the contract. ii. No penalty shall be levied in case of delay(s) in deliverables or performance of the contract for reasons solely and directly attributable to the QCI. iii. QCI reserves the right to invoke the clause 8.28 (i) above in case of unsatisfactory performance of services or non-compliance of any of the terms & conditions of the contract.
