1.	7	Scope of Work	The interested service providers can apply for the empanelment in any of the above categories.
2.	9	Prequalification Criteria; (f) Regional Presence	Deleted; However, the agency shall deploy the technical team in Delhi NCR in case of award of work, if any. A declaration in this regard must be submitted.
3.	9	Prequalification Criteria	The service providers registered as start-ups with DPIIT are eligible to apply. Such service providers are exempted from technical capability and annual turnover criteria. Valid start-up certificate must be submitted along with the proposal.
4.	9	Technical Evaluation	As a part of evaluation of proposals submitted, QCI shall invite the service providers qualifying the pre-qualification criteria for the technical presentation round. The detailed evaluation criteria shall be shared during presentation round. The agencies with the technical score of 70 or higher shall be considered for the empanelment.
5.	3,10	Last date and time for submission of Applications	5:00 PM, Friday, 21 st July, 2023. A copy of technical proposal, in the PDF format, may be submitted to procurement@qcin.org along with the hard copy.

A brief description of the service provider and an outline of recent experience on assignments of similar nature showcasing approach and methodology. 2. All the supporting documents mentioned in the prequalification criteria 3. Any other details that the service provider may like to provide.
