The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. ii. Payment shall be made after submission of invoices within 15 days of receipt of invoice complete in all respect.

iii. Incorrect Invoices, Under/Over Payment: In case an invoice is found to

have been rendered incorrectly after payment, any underpayment or over payment will be recoverable by or from the vendor, as the case may be, and, without limiting recourse to other available means, may be offset against any amount subsequently due by QCI to the vendor under this contract.
